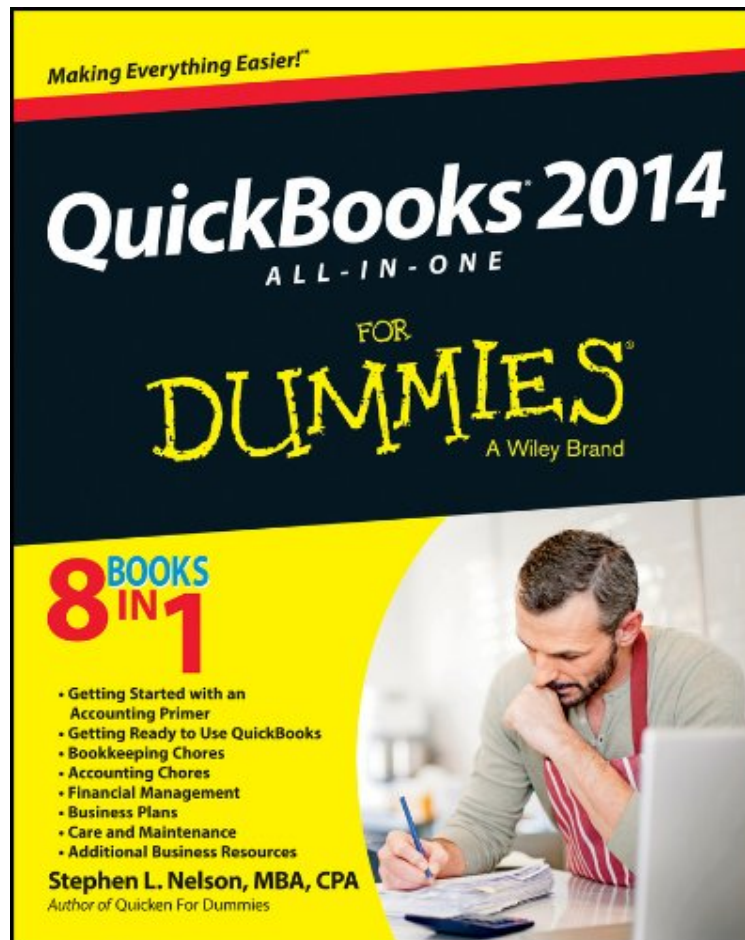

First off, if you have no accounting experience, or have never used QuickBooks Pro then I would purchase a less comprehensive book. It does give you a couple of chapters in the beginning, that attempt to rapidly explain accounting principles. However, in my opinion someone that has no accounting background would be confused, and possibly intimidated by continued use of QuickBooks. That being said, this book does give a comprehensive overview of the program, and is easy to follow if you are familiar with QuickBooks.
